# NEW RATE STRUCTURE

# UPDATE

As you know, Fergus Electric Cooperative implemented a new general service rate structure effective January 1, 2024.

This change was communicated to the membership as a revenue-neutral rate change, meaning that the monthly revenue under the old rates would closely align with the monthly revenue with the new rates.

To date, we have billed our members for the first two months of 2024, and I wanted to share the results.

For the month of January 2024, billing under our old rates would have collected \$1,297,483. Under the new rate structure for January, we collected \$1,293,383 which is a difference of \$4,100, or 0.316 percent.

For the month of February 2024,

billing under our old rates would have collected \$1,097,464. Under the new rate structure for February 2024, we collected \$1,091,591, which is a difference of \$5,872 or 0.535 percent.

With only two months of billing under our belt, I have confidence that the team at Fergus Electric hit the nail on the head in terms of implementing a universal demand billing component across the membership in a revenue-neutral manner.

The rate structure change has affected our membership in different ways. Members with average electric use have noticed slight decreases in their monthly electric bills.

Small energy consumers with average or above-average demand requirements have noticed a slight increase.

Members with large demand requirements have seen an increase of 3 to 5 percent.

We still have 10 months of the year left, and I intend to keep our membership informed. I will provide the next update on our revenue-neutral rate structure change at our upcoming 86th annual meeting, to be held at the Fergus County Trade Center on Thursday, June 6.

I look forward to updating the membership on many of the exciting projects we are wrapping up, including the new office/shop in Roundup, the new 24-mile 50 kilovolt transmission line from Hilger to Winifred, and the reliability upgrades we are implementing with new electronic reclosers throughout the system.

# Call to enroll in the budget billing program

**RE** you interested in enrolling in budget billing? Budget billing does not reduce your overall power bill; it spreads the cost out over a 12-month period.

To qualify for the co-op's budget billing program, the account must have been active at that location for the past 12 months and have a zero-balance due.

Once your account is set up as a budget-billing account, to remain enrolled in the budget billing program each month you must pay the budget amount due, in full, by the due date.

We will automatically remove accounts with two months unpaid balance from the budget billing program. If you choose, you can always pay extra during warmer months so that you build up a cash cushion to use



during the colder months. To ensure your payment is on time each month, we encourage you to consider enrolling in autopay.

True-up occurs every year during the anniversary month of your initial budget billing enrollment. This means whether you have a credit or a balance due; we will adjust your electric billing account accordingly.

We encourage members enrolled in

budget billing to monitor their monthly usage and look at the current charges. Compare last year's usage to the same month's usage in the current year. If there is a significant difference, is there an explanation? If you cannot determine why there is a change in your usage, call the office at 406-538-3465, and we can look at your daily usage history to help identify when your meter began showing more usage. This often helps members determine the cause, i.e., a worn-out refrigerator or a heater left turned on, or perhaps family members have been home more recently.


