- 1. SPECIAL MEETING CALLED TO ORDER. The Fergus Electric Cooperative, Inc. Board of Trustees met in in a special conference call session June 8, 2020 with PRESIDENT PAUL DESCHEEMAEKER calling the meeting to order at 12:30 p.m. JANINE RIFE DIDIER was scrivener. - **2. WAIVE NOTICE OF MEETING.** BOB EVANS moved to waive notice of the conference call meeting. TERRY FROST seconded the motions, which carried unanimously.
- **3.
