MINUTES – JUNE 10, 2021 REORGANIZATION MEETING OF THE BOARD OF DIRECTORS FERGUS ELECTRIC COOPERATIVE, INC.

- 1. **REORGANIZATION MEETING CALLED TO ORDER.** The reorganization meeting of the Board of Directors of Fergus Electric Cooperative, Inc. was called to order by CORPORATE COUNSEL KRIS BIRDWELL at 3:20 p.m. at the Fergus Electric Cooperative headquarters building in Lewistown after the 83rd Annual Meeting of the Membership June 10, 2021. JANINE RIFE DIDIER was scrivener. Board members present were BRAD ARNTZEN, PAUL DESCHEEMAEKER, BOB EVANS, TERRY FROST, CATHY KOMBOL, and BRETT MAXWELL. Due to recent surgery, JASON SWANZ was not in attendance. GENERAL MANAGER CARSON SWEENEY and OFFICE MANAGER SALLY HORACEK were also present.
- 2. APPROVAL OF ACTION OF OFFICERS/BOARD FOR PAST YEAR. TERRY FROST moved to ratify actions of the executive committee, full board, and agents for the board for the past year. BRAD ARNTZEN seconded the motion, which carried unanimously.
- 3. CORPORATE COUNSEL BIRDWELL CONVEYS APPRECIATION. SECRETARY/TREASURER. BOB EVANS nominated JASON SWANZ for the office of Secretary/Treasurer.

ASSISTANT SECRETARY/TREASURER. BRETT MAXWELL nominated BRAD ARNTZEN for the office of Assistant Secretary/Treasurer.

Nominations were closed and the nominated officers were reelected.
